# TERMS & CONDITIONS

2. This agreement will commence upon the Partner accepting these terms and conditions and the Partner's membership of the Program is current as long as the Partner is not in breach of these terms and conditions.
3. The partner may terminate this agreement for any reason with 30 days written notice to TLC.
4. TLC has the right to amend these terms and will post a general notice of changes at [www.theleasingcentre.com.au](http://www.theleasingcentre.com.au) or via email. The Partner's continuing participation in or access to the Program after any changes constitutes your acceptance of the terms as modified.
5. Membership of the Program (except at Platinum level) is free of charge. TLC will provide members with access to the benefits relevant to that level, as detailed at [www.theleasingcentre.com.au](http://www.theleasingcentre.com.au), including access to logos, marketing support, training and other benefits as may be made available.
6. The Partner must, at all times:
  - a. accurately represent TLC's products and not make misleading statements about payments, contracts, credit and terms; and
  - b. use TLC's logo to positively reflect the partnership between the parties and not for any negative purpose; and

The Partner indemnifies TLC to the extent of its liability against any demand, claim, damages, losses or costs arising directly or indirectly from any breach by the Partner or any employee, contractor or agent of the Partner of any term of this Agreement or of any applicable law; or as a result of a claim by any of your customers against you or us in respect of any matter. TLC will not be liable to you for loss of profits or business or for any special, incidental or consequential damages.
